# Silver Jubilee Commemorative Lecture

#### Lecture Synopsis

The lecture deals with various national and international initiatives and technologies that contribute to decarbonizing global value chains. It will emphasize which measures contribute to the reduction of greenhouse gas emissions and highlight which regulations and innovative technological approaches for energy efficiency measures, the circular economy and sustainable production as key factors for successful decarbonization. The lecture will discuss how significant progress towards a sustainable economy can be achieved through cooperation between companies, governments, research and development, society and standardization both nationally and internationally.

# Biography

Professor Holger Kohl is Deputy Director of the Fraunhofer Institute for Production Systems and Design Technology IPK, and Head, Department of Sustainable Corporate Development, Institute for Machine Tools and Factory Management (IWF) at the Technical University of Berlin.



He studied industrial engineering at the Technical University of Berlin and the University of California at Berkeley and began working at the Production Technology Centre Berlin as a research assistant in 1999. After completing his doctorate in 2006, he headed the Business Excellence Methods department at Fraunhofer IPK. He has been Director of the Corporate Management Division at the institute since 2013.

Professor Kohl is a member of the German Academic Association for Production (WGP) and Adjunct Professor for "Strategies for Business Excellence in Service and Industrial Management" at the University of Eastern Finland, Joensuu as well as International Chairman of the CIRP-sponsored Global Conference on Sustainable Manufacturing GCSM and a member of the acatech Circular Economy Initiative Deutschland (CEID). He has been President of the German Intellectual Capital Statement Association (BVWB) since 2021 and Vice-President of the Bauhütte 4.0 association for the promotion of urban construction with renewable raw materials since 2023.
